### What is covered?

The internal movement mechanisms, watch buttons, crystal, case and bezel, crown and stem of the Watch are warranted to be free from defects. This limited warranty also provides coverage for a one-time battery replacement when required, which shall be determined at Asurion's sole discretion.

### What is not covered?

This limited warranty does not cover any damage or defects (1) if there is evidence of excessive wear and tear, (2) if there is evidence of intentional or accidental misuse or abuse, including, without limitation, abuse related to servicing not carried out by authorized service centers, (3) resulting from loss, theft, or Act of God, or (4) if used under conditions which exceed the Watch manufacturer's water resistance guidelines.

### Exclusions and conditions

CONSEQUENTIAL AND INCIDENTAL DAMAGES, INCLUDING WITHOUT LIMITATION DAMAGES FOR LOSS OF USE, ARE NOT RECOVERABLE UNDER THIS LIMITED WARRANTY OR ANY IMPLIED WARRANTIES. We are responsible for postage charges and any insurance for shipment to the service facility. The repaired Watch will be returned to you at the return address that you provide in the continental U.S., Alaska or Hawaii at our cost, or at your cost if you provide a return address located outside the continental U.S., Alaska or Hawaii. When you send the Watch to the service facility, please include a brief description of the problem.
