### Best Movie Award for June 2011

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. THIS IS NOT A PRIZE DRAW BUT A SKILL-BASED COMPETITION.**

Welcome.

Amazon Studios runs a number of best movie, best script and other competitions.

The rules provided below and the rules provided in the [Amazon Studios General Contest Rules Version 2010.1](#) (the “**General Contest Rules**”) are the rules for the Amazon Studios **Best Movie Award for June 2011** (the “**Contest**”). These rules and the General Contest Rules are referred to together as the “**Contest Rules.**”

You accept the Contest Rules by clicking to confirm acceptance or by asking that content you contribute to Amazon Studios be considered for the Contest. If you are accepting the Contest Rules on behalf of a company or other legal entity, you represent that you have the legal authority to bind that company or legal entity to the Contest Rules. If you do not have the legal authority or do not agree to the Contest Rules, you may not participate in the Contest and will not be eligible to receive a Contest award.

The Contest Rules have important information about how we will run the Contest and about rights you grant and obligations you accept by participating in the Contest. Please read them carefully and make sure you understand and agree with them before participating.

1. **Your Eligibility.** To enter the Contest, an Amazon Studios participant must meet the eligibility requirements in the General Contest Rules. Each participant who does so is called an “**Eligible Entrant**” in these Contest Rules. We have the right, but not the obligation, to disqualify entries that do not satisfy all eligibility requirements.
2. **Entry Eligibility.**
  - a. **Movie Eligibility.** To be eligible to be considered for a Contest award, a movie must meet the general entry eligibility requirements in the General Contest

Rules and the following specific entry eligibility requirements (each movie that does so is referred to as an “**Eligible Movie Entry**”):

- i. be contributed by an Eligible Entrant;
- ii. be between seventy (70) and one hundred eighty (180) minutes in length; and
- iii. not have previously won a best movie of the month award on Amazon Studios.

b. **Script Eligibility.** Certain scripts contributed to Amazon Studios may be eligible to receive a portion of the Best Movie Award (as defined below), as we may divide the Best Movie Award among Amazon Studios participants using the approach described below and as set forth in the General Contest Rules. To be eligible to be considered to receive a share of the Best Movie Award, a script must meet the general eligibility requirements in the General Contest Rules and the following specific eligibility requirements (each script that does so is referred to as an “**Eligible Script Entry**”):

- i. be contributed by an Eligible Entrant;
- ii. be part of the Best Movie Project (as defined below);
- iii. be a script for a full-length motion picture; and
- iv. be between eighty-five (85) and one hundred sixty (160) pages in length, in twelve (12) point font and in compliance with the Amazon Studios formatting requirements described at <http://studios.amazon.com/help/submitting-a-script>.

c. **Dialogue Track Movie Eligibility.** Certain dialogue track movies contributed to Amazon Studios may be eligible to receive a portion of the Best Movie Award for the Best Movie (as defined below), as we may divide the Best Movie Award among Amazon Studios participants using the approach described below and as set forth in the General Contest Rules. To be eligible to be considered to receive a share of the Best Movie Award, a dialogue track movie must meet the general eligibility requirements in the General Contest Rules and the following specific eligibility requirements (each dialogue that does so is referred to as an “**Eligible Dialogue Track Movie Entry**”):

- i. be contributed by an Eligible Entrant;
- ii. be a dialogue track movie, which consists of an audio track containing substantially all of the dialogue of an Eligible Script Entry;
- iii. not include narration of non-dialogue elements (e.g., narration of action or setting components in the script);
- iv. not include music or sound effects;
- v. not include any visual imagery (i.e., the screen must be blank); and
- vi. be a wholly original recording that does not incorporate elements of movies (including dialogue track movies) previously contributed to Amazon Studios.

- d. **Entry Eligibility.** “Eligible Movie Entries,” “Eligible Script Entries” and “Eligible Dialogue Track Movie Entries” are referred to together as “Eligible Entries.”
3. **Contest Period.** The contest period commences at 12:00 a.m. Pacific Time on November 16, 2010 and ends at 11:59 p.m. Pacific Time on June 30, 2011 (the “Contest Period”).
4. **Award.** The total award for the Contest is **\$110,000 USD**, consisting of \$100,000 USD for the Best Movie (as defined below) (the “**Best Movie Award**”) and ten \$1,000 USD awards for each Honorable Mention Movie (as defined below) (the “**Honorable Mention Awards**”). The Best Movie Award may be split among multiple Eligible Entrants as more fully described below.
5. **Entry Procedures.** All Eligible Entries will be automatically entered into the Contest. If you do not want your Eligible Entry to be entered into the Contest, you can request that it not be entered using the means we provide on Amazon Studios.
6. **Selection of Best Movie and Honorable Mention Movies.** We will select one Eligible Movie Entry as the Best Movie for the Contest (the “**Best Movie**”), using the process below and the Evaluation Criteria below. We will select ten Eligible Movie Entries for honorable mention commendation (the “**Honorable Mention Movies**”), using the process below and the Evaluation Criteria below.
7. **Division and Payment of the Best Movie Award.** Unlike some contests in which the entire contest award goes to the entry selected as the winner, we may divide the Best Movie Award and pay portions of it to different Eligible Entrants in order to recognize multiple Eligible Entrants who may have contributed, in one way or another, to the development of the Best Movie. The Best Movie Award will be split into an \$80,000 USD “**Movie Share**” and a \$20,000 USD “**Script Share**.” The Movie Share and the Script Share may be divided among the Eligible Entries in the project in which the Best Movie was contributed (the “**Best Movie Project**”). How the Movie Share and the Script Share are divided depends on whether the content first contributed as the Original Property that formed the Best Movie Project is an Eligible Entry. (“Original Property” is defined in the Amazon Studios Development Agreement, available at <http://studios.amazon.com/help/development-agreement>.)
- a. **Movie Share.** We will pay out the \$80,000 USD “**Movie Share**” as follows:
1. If the content first contributed as the Original Property that formed the Best Movie Project is an Eligible Movie Entry, then:
    - i. We will allocate and pay \$50,000 USD to the contributor of the Original Property; and
    - ii. We will allocate and pay \$30,000 USD divided among all Eligible Movie Entries contributed to the Best Movie Project that meaningfully contributed to the Best Movie based on our

assessment of the relative merits and relative contributions of those Eligible Movie Entries, using the Evaluation Criteria.

2. If the content first contributed as the Original Property that formed the Best Movie Project is not an Eligible Movie Entry (for instance, because it was too short to qualify as an Eligible Movie Entry, or was a script, and not a movie): We will allocate and pay \$80,000 USD divided among all Eligible Movie Entries in the Best Movie Project that meaningfully contributed to the Best Movie, based on our assessment of the relative merits and relative contributions of those Eligible Movie Entries, using the Evaluation Criteria.
  3. If more than half of the length of the Best Movie contains an Eligible Dialogue Track Movie Entry, at least \$12,000 USD of the amounts payable under part (a)(1)(ii) or part (a)(2) (i.e., \$30,000 USD and \$80,000 USD, respectively) will be paid to the contributor of the Eligible Dialogue Track Movie Entry.
- b. **Script Share.** We will pay out the \$20,000 USD “**Script Share**” as follows:
1. If the content first contributed as the Original Property that formed the Best Movie Project is an Eligible Script Entry, then:
    - i. We will allocate and pay \$10,000 USD to the contributor of the Original Property; and
    - ii. We will allocate and pay \$10,000 USD divided among all Eligible Scripts in the Best Movie Project that meaningfully contributed to the Best Movie, as determined based on our assessment of the relative merits and relative contributions of those Eligible Script Entries, using the Evaluation Criteria.
  2. If the content first contributed as the Original Property that formed the Best Movie Project is a script but is not an Eligible Script Entry (e.g., because it was too short to qualify as an Eligible Script Entry), then we will allocate and pay \$20,000 USD divided amongst those Eligible Script Entries in the Best Movie Project that meaningfully contributed to the Best Movie based on our assessment of the relative merits and relative contributions of those Eligible Script Entries, using the Evaluation Criteria. If we determine that there are no Eligible Script Entries to which the \$20,000 USD should be payable (for example, because there were no Eligible Script Entries or were no Eligible Script Entries that meaningfully contributed to the Best Movie, based on our assessment), then we will instead add the \$20,000 USD to the Movie Share and pay the \$20,000 USD under part (a) (1) (ii) or part (a) (2), as applicable, of the Movie Share allocation provisions above.
8. **Honorable Mention Award.** For each of the ten Honorable Mention Movies, we will pay out \$1,000 USD to the Eligible Entrant that contributes that Honorable Mention Movie.

9. **Process for Determining the Best Movie and the Honorable Mention Movies.** We may use up to three rounds (any of which we may elect to split into two or more stages) to determine the Best Movie and the Honorable Mention Movies: (i) Audience Feedback; (ii) Analyst Review; and (iii) Judging Panel Determination.
- i. *Audience Feedback.* In this round we will use a variety of audience metrics to narrow down the field of Eligible Entries. One or more of the Eligible Entries selected as a result of this process may advance directly to the Judging Panel Determination round.
  - ii. *Analyst Review.* In this round an analyst will review part or all of an Eligible Entry and score the Eligible Entry using the Evaluation Criteria to further narrow down the field of Eligible Entries.
  - iii. *Judging Panel Determination.* In this round our panel of judges will each review each Eligible Entry and score the Eligible Entry using the Evaluation Criteria to determine the Best Movie and the Honorable Mention Movies.
10. **Evaluation Criteria.** Eligible Movies will be considered based on their relative merit as to any of the following criteria: Premise, Structure, Character, Stakes, Dialogue, Genre Conventions, Visual Style, Acting, Commercial Prospects, and Special Qualities. Eligible Dialogue Track Movie Entries will be considered based on their relative merit as to any of the following criteria: Effective Expression of the Story and Sound Quality. Eligible Scripts will be considered based on their relative merit as to any of the following criteria: Premise, Structure, Character, Stakes, Dialogue, Genre Conventions, Cinematic Value, Commercial Prospects, and Special Qualities.
